\*P3a. Description:  
 This rectangular plan bungalow is surmounted by a moderately pitched front gable roof. The gable overhang is supported by projecting purlins and is trimmed with a plain fascia. There is a small decorative attic vent just below the gable ridge. The exposed rafter tails emphasize the wide eave overhang. The planar front façade of the house appears to result from later alteration which enclosed the original porch, leaving the house with an uncharacteristic cement stoop porch. The entry door and the south window of the front façade are replacement. Other fenestration consists of double hung windows. The building is clad with a narrow novelty siding. Although the craftsman/bungalow origin of the house is still evident in its form, massing and roof treatment, the enclosure of the porch has deprived the building of some of its essential character defining features. The house does not retain its integrity of design, materials, and workmanship and it does not appear to contribute to a district eligible for the California Register.
